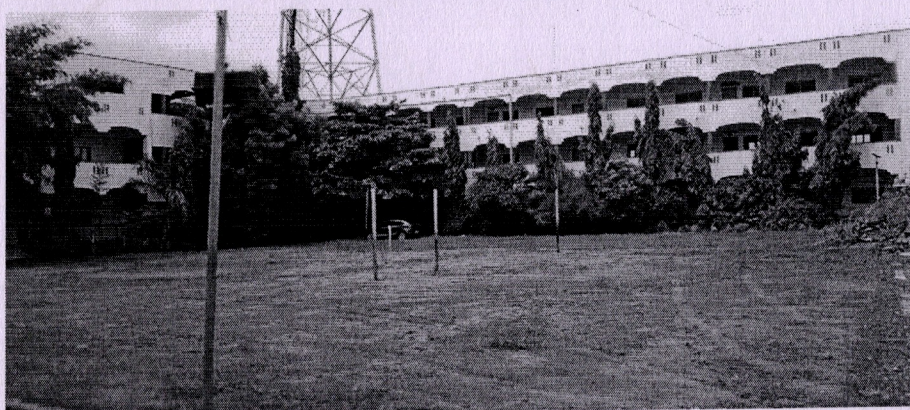

#### PURPOSE:






1. Loins Club of Royal Aurangabad may provide an opportunity to the students and teachers of the said college whenever it undertakes such community welfare program.

4. The activities organized and conducted under this MOU shall be coordinated with IQAC committee.



### 1. Scope of Work


