

WHEREAS:



TERMS & CONDITIONS:

1. As and when the E-Waste material is accumulated in the premises of the party of the FIRST PART, they will inform the party of the SECOND PART, the details of the E waste in writing giving descriptions of the Electronics items and quantities available.

- y of the FIRST PART shall segregate the E-Waste at one designated place within the premises from where the representative of the party of the SECOND PART shall collect the E-Waste.
3. All the Segregated E-Waste shall be stored in the appropriate bins and/or container as prescribed under the applicable law and party of the SECOND PART shall not be liable for any damage caused due to in appropriate storage of E-Waste at the premises by the college.
 4. Upon intimation by the party of the FIRST PART, the party of the SECOND PART shall visit the premises within 15 days there from, arrange for collection of E-Waste as per the applicable provisions.
 5. The party of the FIRST PART shall issue delivery challan before collection of the E- Waste from designated place.
 6. The party of the FIRST PART's liability shall cease once the E-Waste has been collected by the SECOND PART from its premises except for any non-disclosure of any material information known to them with regard to E-Waste during the handover of such E-Waste.
 7. It is specifically agreed and understood that compliances of the applicable law during transportation and disposal of E-Waste shall be exclusive responsibility of the SECOND PART.
 8. It shall be the responsibility of the party of SECOND PART to demagnetize the hard disk before disposing them off in accordance with the terms of the contract.
 9. When the hard disks come along with the CPU the activity would be taken care by the party of the SECOND PART at free or cost.
 10. This Memorandum of Understanding shall be in force for a period of 10 years from the date of signing of this Memorandum of Understanding. Upon completion of the term, the Memorandum of Understanding may be renewed at the caption of both the Parties in writing on mutually agreed terms and conditions.
 11. This Memorandum of Understanding may be terminated by either party without assigning any reason, by giving one month written notice to the other party.
 12. The party of the SECOND PART represents and warrants to the party of the FIRST PART that it has all necessary statutory permissions, consents, approvals and licenses to carry out business of collection, transportation, storage, management and disposal of E-Waste and it shall maintain all such permissions, consents, approvals and licenses during the term of this Memorandum of Understanding. The party of the SECOND PART shall exercise all safety precautions and best Management practices required by law in providing service under this Memorandum of Understanding. The party of the SECOND PART shall notify the party of the FIRST PART immediately if any permit, license, certificate, consent, approval or Identification number required for the performance of its service under this Memorandum of Understanding has been revoked, modified, expired, suspended or not been renewed.
 13. The party of the SECOND PART shall comply with all applicable laws, rules and regulations and shall indemnify and hold the party of the FIRST PART harmless in this regard.
 14. The party of the SECOND PART agrees and acknowledges that the party of FIRST PART or its authorized agent shall have the right to perform environmental and safety audit at any site at which the party of the SECOND PART is conducting E-Waste management services for the purpose of verifying environmental and safety procedures following by the party of the SECOND PART.




